**Sub: Recognition Certificate for the School under sub-rule (4) of rule 11 of Right of Children to Free and Compulsory Education Rules, 2009 for the purpose of Section 18 of Right of Children to Free and Compulsory Education Act,2009.**

Dear Sir/Madam,

With reference to your application dated 16-12-2025 and subsequent correspondence with the school/inspection in this regard, I convey the grant for provisional recognition to the **Chirang Public School, Kajalgaon Ward No.1, Baikungaon, P.O. Kajalgaon for Class-I to Class- VIII** for a period of three years w.e.f. **01-12-2025 to 01-11-2028**.

The above sanction is subject to fulfilment of following conditions:-

- (1) The grant for recognition is not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class VIII.
- (2) The School shall abide by the provisions of Right of Children to Fee and Compulsory Education Act,2009 (Annexure I) and the Right of Children to Free and Compulsory Education Rules,2010 (Annexure-II).
- (3) The School shall admit in class Nursery, to the extent of 25% of that strength of that class, children belonging to weaker section and disadvantaged group in the neighbourhood and provide free and compulsory elementary education till its completion. Provided further that in case of pre- primary classes also, this norm shall be followed.
- (4) For the children referred to in paragraph 3, the School shall be reimbursed as per Section 12 (2) of the Act. To receive such reimbursements school shall provide a separate bank account.
- (5) The Society/School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
- (6) The School shall not deny admission to any child for lack of age proof. If such admission is sought subsequent to the extended provided prescribed for admission. On the ground of religion, caste or race, place of birth or any of them. 21.

(7) The School shall ensure:

- (a) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
- (b) No child shall be subjected to physical punishment or mental harassment.
- (c) No child is required to pass any board examination till the completion of elementary education.
- (d) Every child completing education shall be awarded a certificate as laid down under Rule 23.
- (e) Inclusion of Students with disabilities/special needs as per provision of the Act.
- (f) The teachers are recruited with minimum qualifications as laid under section 23(1) of the Act.

Provided further that the current teachers who, at the commencement of this Act do not possess minimum qualification shall acquire such minimum qualifications within a period of 5 years.

(8) The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.

(9) The school shall enrol students proportionate to the facilities available in the school as prescribed in the section 19 of the Act.

(10) The school shall maintain the standards and norms of the school as specified in section 19 of the Act. The facilities reported at the time of last inspection are as given under:-

- Area of school campus: **10 Bigha,**
- Total built up area: **1021.933 Sq. Mtrs.**
- Area of playground: **02 Bigha**
- No of class rooms: **15 Rooms.**
- Room for Headmaster-cum-Office-cum-Storeroom: **1+1**
- Separate toilet for boys and girls: **10 Nos. for boys & 8 Nos. for girls**
- Drinking Water Facility: **2 Aquagaurd & Tap facilities**
- Kitchen for Cooking Mid-Day Meal: **N/A**
- Barrier free Access: **Yes,**
- Availability of Teaching Learning Material/Play Sports Equipment's /Library: **Yes**

11. No unrecognized classes shall run within the premises of the school or outside in the name of school.

12. The school building or other structures or the grounds are used only for the purposes education and skill development.

13. The school is run by a society registered under Societies **Registration Act, 1860(21 of 1860)** (Act under with Society is registered), or a public trust constituted under any law for the time being in force.

(14) The accounts should be audited and certified by a Chartered Accountant and proper accounts should be sent to the DEO every year.
